Statements from Leaders and Organizations Supporting America's College Promise Act

Statement by J. Noah Brown, President and CEO of the Association of Community College Trustees

"Investments in community colleges and students have shown to be of great economic and societal benefit. For every public dollar spent on community colleges there is a \$6.80 return in the form of higher tax receipts and less public assistance. Over the course of their careers individuals with an associate's degree will earn nearly \$500,000 more than high school graduates. We strongly support structuring this program to support low-income Pell Grant students by preserving the availability of the award for full cost of attendance. This will allow students to borrow less, and potentially persist at a faster rate. Additionally, we support requirements that ensure states continue to invest in higher education."

Statement by Dr. Michael Lomax, President and CEO of the United Negro College Fund

"This legislation is a game-changer for reducing the cost of college, lowering student debt, expanding educational opportunity, and closing the educational divide for millions of students, particularly students of color who otherwise could not enter the college door. HBCUs have earned the right to be called America's best buy for students and the nation. HBCUs produce nearly 20 percent of all African American bachelor's degrees, yet they do this with less resources and at affordable costs for their students. Congress was very wise to include HBCUs as a key component of this program, as they consistently outperform other institutions at educating students from low-income families. This bill will ensure that more deserving students get the opportunity to go to college and build a better future for themselves and our country."

Statement from Carrie Billy, President and CEO of the American Indian Higher Education Consortium

"Enactment of this legislation will mean that more American Indians and Alaska Natives will be able to access – and most important, complete – a degree program in a field that will help our tribes grow their Native workforce. Tribal colleges are locally-based, tribally-driven institutions of higher education that award predominately two-year associate degrees and certificates to Native students and others throughout Indian Country. TCUs serve some of the poorest communities in this country (seven of the 10 poorest counties in the U.S. are home to a tribal college). More than 70 percent of our students are first generation college students and almost 75 percent receive Pell grants. These students, their tribal communities, and the nation as a whole, will benefit tremendously from the America's College Promise legislation."

"The legislation as introduced embodies a dramatic new concept in national education policy, ensuring that first-time students will be able to enroll in high-quality community college programs without having to pay tuition and fees. We believe that this policy will encourage more students to participate in college and succeed. It will do so both by reducing lingering financial barriers, as well as sending a clear and resounding message to the public that college attendance should be as universal as high school."
