Dear Mr. Clark:

I am writing regarding the Department of Education's (Department) recent decision to drop its requirement that Ashford University post a \$103 million letter of credit as a condition for continued receipt of federal student aid.¹ As part of the proposed conversion, Zovio had previously announced that it had entered into a nonbinding agreement of intent to sell Ashford University to a nonprofit entity named the Ashford University non-profit entity.² The Department had previously stated that because the Ashford University non-profit entity was a new entity and lacked 2 years of audited financial results, that within ten days of the change in ownership Ashford University would have to post a letter of credit equal to the value of twenty five percent of the Title IV funding received in fiscal year 2018.³ This requirement was dropped by the Department in July⁴, and Zovio announced that it would instead sell Ashford University to the University of Arizona.⁵

Additionally, according to statements filed with the Securities and Exchange Commissions (SEC), Zovio expects a failing financial composite score of 0.7 for the fiscal year that ended December 31, 2019.⁶ Under Department regulations, institutions with a score of less than 1.0 are considered not financially responsible.⁷ Institutions that are designated not financially responsible can participate in Title IV under provisional certification, subject to heightened cash monitoring, and after posting a letter of credit equal to at least 10 percent of the Title IV funding received in the most recent fiscal year.⁸

In order to assist the Committee's ongoing oversight of this matter, I am requesting that Zovio produce the following by September 4th, 2020:

- 1. FY 2019 audited financials for both Zovio and Ashford University.
- 2. All communications with the Department regarding the letter of credit requirement and the proposed conversion and sale to the University of Arizona.
- 3. All communications with the Department regarding financial composite scores and letter of credits at either Ashford University or Zovio.
- 4. All communications with the Western Association of Schools and Colleges regarding the proposed conversion and sale to the University of Arizona.
- 5. All communications with Ashford University's not-for-profit entity regarding the conversion, including the nonbinding letter of intent announced on December 30, 2019.
- 6. All communications with the University of Arizona or the University of Arizona Global Campus regarding the purchase of Ashford University.
- 7. All communications with former Zovio executives Robert Eitel and Scott Filter since they joined the Department of Education.
