Dear Secretary DeVos:

I write in response to the Department's letters to the Committee from November 7, 11, and 14. Throughout the approximately 10 months that I have been Chairman of the Committee, I have sought information from the Department on Borrower Defense, but regrettably the Department has avoided oversight at nearly every opportunity. Last night, however, I was informed that today the Committee "will receive updated Borrower Defense information requested by the Committee in March and June of this year." Now that the Department has agreed to produce these documents, the Committee can begin its oversight of this program and gain an informed understanding of the Department's failure to timely adjudicate the claims of 210,000 borrowers.

The Committee hopes that the forthcoming document production is fully responsive to the requests made over the last ten months. The Committee reserves its right to compel additional documents if, upon review, we determine the production is not completely responsive.²

The Department has asserted that General Brown is willing to brief the Committee on Borrower Defense. I would like to *again* accept this offer. Please contact Committee staff to arrange a mutually agreeable time for General Brown to brief the Committee on Borrower Defense implementation within the next two weeks.
