



### Organizations Voicing Concern or Opposing H.R. 4508

Nearly 550 organizations spanning higher education, civil rights, veteran services, consumer protection, and public sector service communities have written Congress to demand significant revisions to H.R. 4508, the GOP bill to reauthorize the Higher Education Act and cut billions from financial aid. The bipartisan Public Service Loan Forgiveness Caucus has expressed concerns, and the Congressional Tri-Caucus is opposed to the bill.

Not surprisingly, the Career Education Colleges and Universities (CECU) trade group, an association representing for-profit colleges, has endorsed H.R. 4508. On the same day of introduction, CECU praised the bill for “fairness and balance in higher education policy.”
