## American Rescue Plan:

### *Family Violence and Child Abuse Prevention Funding Estimates*

The [FY21 Budget Reconciliation](#) provides critical support to protect the health and well-being of children, families and survivors of domestic and gender-based violence. The bill:

- Helps prevent and respond to child abuse and neglect by providing **\$350 million** for the *Child Abuse Prevention and Treatment Act (CAPTA)*.
- Strengthens our response to domestic and gender-based violence by providing **\$450 million** in support for survivors, including funding for rape crisis centers and programs to support survivors of color under the *Family Violence Prevention and Services Act (FVPSA)*.
