## Dear Director Swagel,

Last month the U.S. House of Representatives passed H.R. 1, which included several proposals within the jurisdiction of the Education and Workforce Committee that would significantly alter access to federal student aid.<sup>1</sup>

Last month, the Congressional Budget Office (CBO) published cost estimates of H.R. 1 which included estimates on changes to Pell Grant eligibility in Section 30031 of the bill. CBO estimates that changing the definition of full-time enrollment from 24 credits to 30 credits would reduce direct spending by roughly \$7.1 billion over ten years. Eliminating eligibility for students enrolled less than half time is estimated to reduce direct spending by \$687 million over ten years. The CBO estimate did not provide information about the number of students who would be affected by these proposed changes.

Therefore, I am requesting CBO to provide my office with an estimate of how many students would be impacted by the proposed Pell Grant eligibility changes. Specifically:

- 1. How many students would see a decrease in their Pell Grant award due to the proposed change to the definition of full-time enrollment in Sec. 30031(b)?
- 2. How many students would either lose their Pell Grant or receive a smaller award due to the proposed Pell Grant ineligibility for students enrolled less than half time in Sec. 30031(d)?
