Dear Chairman Walberg:

As the Ranking Member of the Committee on Education and Workforce (Committee), I write to follow up on a previous request¹ that the Committee immediately hold an oversight hearing regarding the activities and proposals of the U.S. Department of Health and Human Services (HHS or the Department). The urgency of an oversight hearing is exacerbated by the recent termination of 4,623 dedicated public servants on July 14, 2025,² and HHS' continued lack of transparency surrounding its reorganization plans.³ Per Rule X of the Rules of the House of Representatives, the Committee has a jurisdictional and oversight responsibility to assess how HHS' actions align or conflict with its statutory duties.

The Committee usually has the opportunity to hear from the Secretary during an annual budget hearing to discuss the policies and the priorities of the Department. To date, this hearing has not occurred this year. Further, we have not yet received comprehensive information from HHS regarding the impacts of the proposed reorganization and the reductions in force (RIFs) undertaken by the Department. These actions threaten the core functions of essential programs. For example, the Administration for Community Living (ACL) is vital to support older adults and people with disabilities, yet the agency is slated for elimination, and 90 full-time employees

were terminated on July 14, 2025.⁵ Democrats on the Committee also have little information on the layoffs that may have been administered by mistake on April 1, 2025,⁶ as well as any possible mistakes made in the July 14, 2025, terminations.

As these questions remain unanswered, I urge a full Committee hearing to examine the full extent, intentions, and impacts of the Department's RIFs and proposed restructuring. Most importantly, the Committee needs to fulfill its responsibility to assess fully whether the Department is fulfilling its obligations under laws within the jurisdiction of the Committee. As the dismantlement of key programs threatens health and wellbeing, Congress and the American public deserve transparency.
