Dear Chairman Thornberry and Ranking Member Smith:

As President of the Shipbuilders Council of America, I am writing to urge your support for maintaining the inclusion of the Maritime Advisory Committee for Occupational Safety and Health (MACOSH) provision in the National Defense Authorization Act for Fiscal Year 2017. MACOSH is a 15-member committee which was established to advise OSHA on standards and policies affecting the maritime industry (U.S. Navy and commercial shipbuilding/repair, longshoring and maritime terminals)--an industry which is extremely complex and high-risk. According to OSHA, "the insight OSHA receives from the Committee is invaluable in reducing the amount of work-related injuries and illnesses." MACOSH is a "discretionary" committee, and must be re-justified and re-chartered every two years pursuant to the Federal Advisory Committee Act (FACA).

MACOSH's work is repeatedly interrupted because charters have not been renewed in a timely manner. These lapses in charter distract MACOSH away from its mission to provide a collective expertise, not otherwise available to the Secretary of Labor to assist in addressing the unique hazards found in shipyard and marine cargo handling activities. It is vital our U.S. Navy and commercial shipbuilders work in accordance to the safest industry standards and procedures so those workers can return home at the end of the day.

This advisory committee provides industry a venue for constructive agency/stakeholder dialogue that ultimately protects lives at work and stabilizes our manufacturing sector. Any efforts to remove this important provision from the NDAA would eliminate a critical check on and window into the Labor Department in implementing regulations that will ultimately impact our industry.

By stabilizing this Advisory Committee, the shipbuilding industry will maintain consistent safe and regulatory compliant work environment, thus making the industry more attractive to workers and reducing employer noncompliance violations. It is only through MACOSH these shippards have the forum to develop best practices in safety and health.

We request your support for maintaining the inclusion of the National Defense Authorization Act for Fiscal Year 2017 amendment to the Occupational Safety and Health Act (OSHAct) to establish MACOSH as a continuing statutory advisory committee.
