# ORKING FAMILIES REPORT CARD: DELAWARE

Across the nation, people are working harder than ever, but too many families are still struggling to make ends meet. For many hardworking people in Delaware, it's been too long since they got a raise; workplace policies make it nearly impossible for people to both care for and provide for their families; and discrimination shuts too many people out of good-paying jobs. It does not have to be this way. Democratic lawmakers in Congress have introduced responsible solutions to help Americans make a better life for themselves and their families.



# **ACROSS THE NATION & IN THE STATE**

#### MINIMUM WAGE

Full-time, year-round work at the current federal minimum wage of \$7.25 leaves a family of three below the federal poverty line. In Delaware, 100,000 people will benefit from an increase in the federal minimum wage to \$12 by 2020.



# PREGNANT WORKER FAIRNESS

There are 2.4 million pregnant women in our nation's labor force—all too often they are denied explicit reasonable job accommodations. In Delaware, there are 8,148 pregnant women in the labor force.



# LGBT EQUALITY

Lesbian, gay, bisexual, and transgender (LGBT) individuals are more likely to have low incomes in states that lack explicit protections from discrimination-3.4 percent of Delawareans identify as LGBT.

# AFFORDABLE CHILD CARE

Only one in six children eligible for federal child care assistance actually receives it. In Delaware, there is no waitlist for childcare subsidies.



#### **PRE-K ACCESS**

Nationwide, only three in ten four-year-olds are currently enrolled in a high-quality preschool program. Only 2.9 percent of 3- and 4-year-olds in Delaware are enrolled in state prekindergarten programs.

# **EQUAL PAY**

Nationwide, women working full-time, year-round typically make only 79 cents for every dollar a man makes. On average, women in Delaware make only 81 cents for every dollar paid to their male counterparts. Compared to their white male counterparts, Asian American women earn 90.2 cents on the dollar, African American women earn 68.6 cents on the dollar and Latina women earn 57.2 cents on the dollar.

# SICK LEAVE

Across the nation, 43 million workers do not have access to a single day of paid sick leave. In Connecticut, 40 percent of workers lack access to paid sick leave.
